**By signing below, I agree to the following Country Club at Mirasol Community Association, Inc. (CCMCA) transponder policies and procedures:**

- Only Mirasol residents may purchase and use transponders.

- Residents that are not on the warranty deed of the home must provide proof of residency to purchase and use transponders.
- Defective transponders may be returned within thirty (30) days from the date purchased for a replacement device at no additional charge. Refunds will not be issued.
- Damaged transponders are not replaceable.
- Certain vehicle windshields prevent the transponder signal from registering, and the device must be held outside the vehicle window to open the gate.
- Yearly re-registration of all transponders is required. If this is not complete, transponders are subject to deactivation.
