NEED A MIRASOL VENDOR ID CARD?

REGISTER FOR YOUR MIRASOL ID CARD

Mirasol Security has implemented a "Community Identification Card" system for community access. All vehicle operators of Mirasol contractors, Mirasol vendors, and Mirasol employees **ARE REQUIRED TO PURCHASE** an identification card. The cost for new cards is \$25 each.

ALREADY HAVE A MIRASOL ID CARD?

RE-REGISTER YOUR MIRASOL ID CARD

Those of you that currently have a Mirasol ID Card will soon have to renew the card as it **expires one year** from the date you originally purchased it. On or after May 3, 2011 cards will begin to expire. Before your card expires you will have to fill out a new application with any updated information. Your card will then be re-activated for another year. The cost of renewing your card is \$15 each. **PLEASE DO NOT WAIT UNTIL THE CARD EXPIRES.**

Drivers without a Mirasol ID may be refused entry into the community.

All persons registering or re-registering **MUST** bring a completed registration form, a valid U.S. Driver's License, payment, and a current vehicle registration in order to obtain a Mirasol ID.

MIRASOL COMMUNITY RULES

1. Mirasol vendor identification cards are to be used by its authorized owner only.
2. Any unauthorized person found using a card will be subject to trespassing violations and issued a fine of \$100. The card will be confiscated and the owner of the card will also be issued a fine of \$100.
3. The CCMCA has the right to refuse entry at anytime.
4. Solicitations of any kind are not permitted under any circumstances.
5. No animals/pets.
6. No guns or weapons are permitted on Mirasol property.
7. Obey all traffic laws; the speed limit is 25 mph, strictly enforced. *Fines will be imposed.*
8. Parking is allowed on the **right side** of parcels as you enter and, in designated areas only. Parking in a cul-de-sac is not permitted.
9. Do not block driveways, sidewalks, mailboxes, or fire hydrants.
10. Vehicles parked illegally or left on property overnight may be towed at the owner's expense.
11. Applicable hours of construction are Monday through Friday 7:00 a.m.- 5:00 p.m. and Saturdays 8:00 a.m.- 4:00 p.m.
12. Construction on Sundays is by permission only.
13. Construction vehicles are not allowed to enter the community after 5:00 p.m. Construction is not allowed on legal holidays.
14. Construction traffic must enter and exit through the east gate on Jog Road.
15. Vendors are responsible for proper disposal and removal of their own trash.
16. Drugs and alcohol are not permitted.
17. No glass containers.
18. Theft or destruction of property will be dealt with to the fullest extent of the law.
19. Do not feed or harass the wildlife.
20. Do not swim or fish in any of the lakes.
21. Do not alter or destroy the native vegetation.
22. Entry and use of both golf courses is strictly prohibited unless permission is given otherwise.
23. The CCMCA reserves the right to inspect all vehicles entering and leaving the community.
24. No loud music or disturbing noise is permitted by any contractor or workers after 5:00 p.m.

By signing below, I certify that the information I provided is true and correct to the best of my knowledge. I understand that the Mirasol ID is the property of the CCMCA and I agree to immediately surrender it upon request from an authorized representative of the association and also to return the pass immediately upon termination of my job or work responsibilities. I further agree to abide by the rules of Mirasol community as stated on this form, and I understand that violation of the rules may result in the loss of my Mirasol ID, and/ or community access.
